

## Orascom Development Egypt (ODE) completes landmark land sale in El Gouna for EGP 1.54 billion, 15 times its book value.

Cairo, 2 July 2024 - Orascom Development Egypt (ODE) is pleased to announce the sale of 145,266 sqm of land in El Gouna for EGP 1.54 billion (USD 225/sqm). The land sale, executed at roughly 15 times its book value of EGP 101 million, marks a significant milestone for ODE as it represents the most extensive land sale in El Gouna since 2015. Notably, this land plot is situated at the backend of El Gouna's developed area.
